Property crimes are up 60% and person's crime up 31% over this time last year There was a shooting of someone who was trying to sell something on Craig's List If you are out walking your dogs and you don't see anything, please contact the Denver police department

Mike Fatica asked about the best way to report suspicious activities; Officer Munson suggested calling 911 if there are suspicious activities like someone "selling security; The data is available on the crime map and this is used for the data Aggravated Assault is how gun shots is reported when looking at the crime map Communitycrimemap.com is the location

Denver Police uses "Shots Fired" or "Shots Tracker" or "<u>Shots Spotter</u>" Crime Stopper and to use technology to link the crimes; it will track and link shootings It tracks shots within 15 feet of their occurrence Is it possible to access the log of the shots fired? There may be multiple visits to a location to determine the location of shell casings;

Some of the recent crimes have been built around transactions over Craig's List; it is typically a larger cash transaction when someone is selling something like a phone. When someone arrives with cash, they may be robbed. Officers suggested that any such transactions be done in a public place like a police station for safety;

There have been large groupings of bikes in certain areas within the neighborhood. Officers will scan the serial number and if the number is reported as stolen then police will confiscate.

For non emergencies like someone living in a car or a large homeless tent community that has developed, call 311

Question was asked about how citizens can get more information on shootings when the occur; Unlawful discharge of a weapon

---officers said that there needs to be a better way to learn about share information with community members

Some frustration that neighbors were uninformed when there are incidents like multiple gunshots fired

When you call in, the responder should ask if you want to file a complaint;

If there is a property with "riffraff", how do you respond to it, i.e. there is a drug activity at an apartment complex or a house;

If you see the activity, it should be called in;

You can call in directly to district 6 to the Community Resource Officer and the can fill out the appropriate form like increased patrol;

Increased police presence to help curtail and discourage crime;

What can neighbors do to combat gang activity? Take pictures and submit on Pocket Gov

Police department is working to reduce the fear of crime as well;
